MAPLight.org illuminates the connection between money and politics. Our groundbreaking transparency website combines campaign contribution information with how every legislator votes on every bill.

Facts generated by our website and research reports, covering topics from health care to climate change to the financial bailout, reached more than 11 million people from Jan. 2008 through May 2009, including stories on CNN, Marketplace, the Economist, Wired.com, and dozens of other television stations, radio shows, newspapers and blogs across the country. Our free public website, updated daily, educated over a quarter of a million visitors about money, votes and bills in the U.S. Congress.

This year we successfully settled our freedom of information lawsuit against the state of California, winning public access to the state's database of how state lawmakers vote.

In May 2009 we launched a new MAPLight.org site providing unprecedented money and politics transparency for the second largest city in the country, Los Angeles. New government transparency tools we launched this year include:

- Money and Votes widget: Shows money/vote correlations for any bill and vote. These and our Congressional and Presidential Fundraising widgets appeared on 17,000 web pages and were viewed 3 million times.
- U.S. Congress API: An 'application programming interface' which provides a live feed of MAPLight.org's original research on company, organization and interest group positions on key bills in Congress.
- Community comment system: A sophisticated user-generated comment system that lets any site visitor post commentary about legislators, bills and issues.
- 'Committees' tab: Reveals information on special interest contributions to members of each Congressional Committee.
- 'Remote Control' report: The first-ever study of the geography of campaign contributions to members of Congress, using street-level address detail. We found that 79% of House members' campaign contributions came from outside their districts.

We won several awards, including a Library Journal "Best Reference" for 2008, a Knight-Batten Award for Innovations in Journalism, and a James Madison Freedom of Information Award from the Northern California chapter of the Society of Professional Journalists.
